

# El Rancho Supermercado Official 24 Days Event Rules

## ("Official Rules")

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE 24 DAYS EVENT. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

PARTICIPATION IN THE 2025 24 DAYS OF GIVEAWAYS EVENT ("24 DAYS EVENT") CONSTITUTES YOUR AGREEMENT TO BE BOUND BY THESE OFFICIAL RULES. THESE OFFICIAL RULES ARE SUBJECT TO BINDING ARBITRATION AND A WAIVER OF CLASS ACTION RIGHTS AS DETAILED IN SECTION 11, BELOW.

**1. 24 DAYS EVENT PERIOD:** The 24 Days Event begins from 1:00 AM Central Standard Time ("CST") on December 1, 2025, and ends at 11:00 PM CST on December 24, 2025 ("24 Days Event Period"). Mexico Foods, LLC ("Sponsor" or "El Rancho Supermercado") computer is the official time-keeping device for the 24 Days Event.

**2. ENTERING THE 24 DAYS EVENT:** Official entries for Sponsor's 24 Days Event will be available on the El Rancho Supermercado app, which you can download in the App Store or the Google Play store (collectively the "**App**"), El Rancho Supermercado social media pages, in store at El Rancho Supermercado locations, and online through El Rancho Supermercado e-commerce platforms. On select days during the 24 Days Event Period, a sweepstakes will be held, and one winner will be chosen from that day's entries. The winner will be announced the following day. On other days, a giveaway may be offered instead, where all eligible participants can receive a prize without a drawing. For entries into the sweepstakes, one entry per day is permitted. For sweepstakes entries submitted untimely or outside the guidelines provided in the Official Rules shall be deemed VOID for that day. The prize and method of entry for each day are as shown below in Section 4.

**Alternative Method of Entry ("AMOE"):** For sweepstakes entries, Participants may enter the 24 Days Event by sending an email to [Communications@Heritagegrocers.com](mailto:Communications@Heritagegrocers.com) with their Name, Email Address, Phone number, address, and the address of the El Rancho Supermercado which is closest to their location. One Entry per day may be submitted through AMOE. Entries through the AMOE will only be valid for the day on which the email is received by Sponsor and the Participant will only be eligible to win the prize for the same corresponding day.

**3. ELIGIBILITY:** In addition to eligibility requirements specified in the applicable Post, Participants must also (1) have access to internet, (2) have an internet-capable device, (3) have access to the email address connected to their App or AMOE, (4) be a legal US resident, (5) live within 30 miles of at least one (1) El Rancho Supermercado retail location, and (6) at least eighteen (18) years of age at the time of entry.

There is no charge to sign up for the App or to enter through the AMOE. Standard data charges may apply if participating through a mobile device. Data rates may apply for each message sent or received from a device according to the terms and conditions of Participant's service agreement with their wireless carrier if accessing or entering 24 Days Event through a mobile

device. Other charges may apply and may appear on a mobile phone bill or be deducted from a prepaid account balance. Wireless carriers' rate plans may vary, and Participants are encouraged to contact their wireless carrier for more information on messaging rate plans and charges relating to the participation and entry in the 24 Days Event. Mobile device service may not be available in all areas. Sponsor is not responsible for any charges.

Employees of Sponsor and their affiliates and subsidiaries (collectively "Promotion Parties"), and members of such employees' immediate family or persons living in the same household as such employees are not eligible for entry into the 24 Days Event. The foregoing eligibility requirements are void where prohibited.

All entries must comply with (1) the applicable guidelines, rules or standards of the App, (2) the Official Rules, and (3) any other requirements set forth by Sponsor. Entries that do not conform to the preceding sentence may be deleted and/or no entry will be generated or considered. Sponsor reserves the right to reject or disqualify any entry which Sponsor, at its sole discretion, determines to be inconsistent with the letter or spirit of the Official Rules or potentially damaging to the Sponsor's, the 24 Days Event', or another's image or reputation. If applicable, entries must only include the information required for entry into the 24 Days Event, and must not: depict, encourage, promote or induce conduct that could violate any law, regulation or ordinance, or give rise to criminal or civil liability, or that could be considered, in Sponsor's sole discretion, risky, violent, discriminatory or otherwise inappropriate; depict, encourage or promote the use of alcohol, illegal drugs, tobacco, firearms/weapons, or any particular political agenda or message; contain any content that is protected by trademark, copyright, trade secret, right of publicity or other proprietary right, without the express prior written consent of the owner of such right; contain any personal information, such as phone numbers, license plate numbers, e-mail addresses or street addresses; contain messages or images inconsistent with Sponsor's image and/or goodwill; contain any content that could be considered deceptive, misleading, false, fraudulent, scandalous, indecent, obscene, sexually explicit, defamatory, libelous, threatening, harassing, hateful, degrading, intimidating, graphically violent or otherwise unlawful, tortious or objectionable, as determined by Sponsor in its sole discretion; depict any individual other than the Participant, unless the Participant has received the written permission of such individual (or of his/her parent or legal guardian in the event that he/she is a minor); and/or contain any confidential information or any material, non-public information about any company or individual.

**4. PRIZES:** The 24 Days Event prizes shall be given away daily as shown below. No substitution or transfer of prizes are permitted; however, Sponsor reserves the right to substitute a prize of equal or greater value at any time while the 24 Days Event are in effect. If a potential Winner is not eligible to receive a prize for any reason, including as described in Sections 3 and 5, Sponsor may, at its sole discretion, award the applicable prize to another

Potential Winners will be posted on our website at <https://www.Elranchoinc.com/24-days-of-giveaways/> the next day and contacted via the email they used when signing up for the AMOE or App. Following such notification, Sponsor may send potential Winners a Sponsor Release Agreement. If requested by Sponsor, potential Winners must sign and return the required Sponsor Release Agreement within seven (7) days of receipt of such document, or such other date set by Sponsor, in order to receive the prize. Documents requested by Sponsor may be submitted through a designated, secure third-party service such as SharePoint, Dropbox, Google Drive or any other link provided by Sponsor. Once Sponsor receives all requested documents through the designated link (or other delivery method approved by Sponsor), Sponsor may engage potential Winners with follow-up communications regarding prize disbursement such as pick-up location, date and time. PARTICIPANT FURTHER AGREES THAT ANY LEGAL SUIT, ACTION, PROCEEDING, DISPUTE, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THE 24 DAYS EVENT, POST, THESE OFFICIAL RULES, AND THE PRIVACY POLICY, SHALL BE BROUGHT EXCLUSIVELY IN THE STATE COURTS OF TEXAS LOCATED IN DALLAS COUNTY, TEXAS OR THE UNITED STATES DISTRICT COURT FOR THE NORTHERN DISTRICT OF TEXAS.

accordance with and subject to the terms of the Sponsor's Privacy Policy, available at <https://www.elranchoinc.com/politica-de-privacidad/>, ("Privacy Policy"), which is incorporated by reference as if re-stated in full herein.

**10. SPONSOR:** Mexico Foods, LLC 2501 East Guasti Rd. Ontario, CA 91761. This 24 Days Event is in no way sponsored, endorsed, administered or affiliated by or associated with Meta Platforms, Inc., or any applicable Social Media Platform, and each of their respective employees, officers, directors, agents, representatives, owners and managers.

**11. MANDATORY ARBITRATION:** As a condition of participating in the 24 Days Event, except where prohibited by law, you agree that any dispute, claim, or controversy arising out of or relating to the 24 Days Event, Post, the award of a prize, or the breach, termination, enforcement, interpretation, or validity of these Official Rules, shall be submitted to and determined by JAMS exclusively on an individual, non-class basis pursuant to its Comprehensive Arbitration Rules and Procedures and in accordance with the Expedited Procedures in those Rules. For the avoidance of doubt, you agree that any and all disputes, claims, and causes of action arising out of or related to 24 Days Event, Post or any prize awarded shall be resolved individually and not in the form of any class action or other form of representative action. You agree that, as a condition of participating in the 24 Days Event, you and all Participants waive any right to bring any action arising from or related to the 24 Days Event, Post or the award of a prize as a class or other representative action.

The arbitration shall be held before a single arbitrator, who shall be an attorney at law and an experienced commercial and contract law arbitrator. You and the Sponsor shall evenly split the cost of the arbitration, including the compensation of the Arbitrator and all administrative expenses. The parties may be represented by their own attorneys in the arbitration proceeding and, except as may otherwise be required by law, shall be responsible for their own attorneys' fees and costs incurred in presenting their case to the Arbitrator. The Arbitrator shall have the power to award all legal relief available in a court of law, including any and all damages that may be available for any of the claims asserted, provided, however, that the arbitrator may not award any incidental, indirect, or consequential damages, including damages for lost profits, or any other relief waived under this Agreement. In addition, each of the parties shall retain all defenses that they would have in a judicial proceeding, including defenses based on the expiration of the statute of limitations and that the damages being sought are not authorized or are excessive. The Arbitrator shall render a written award within thirty (30) days after the matter is submitted for determination, and the award of the arbitrator shall be final and binding on the parties. Judgment on the award may be entered in any court having jurisdiction. This provision, however, shall not preclude the parties hereto from seeking provisional remedies in aid of arbitration from a court of appropriate jurisdiction, including preliminary injunctive relief.

YOU AGREE AND ACKNOWLEDGE THAT THE 24 DAYS EVENT EVIDENCES A TRANSACTION INVOLVING INTERSTATE COMMERCE AND THAT THIS AGREEMENT IS ENTERED INTO UNDER THE FEDERAL ARBITRATION ACT ("FAA"). ACCORDINGLY, THIS AGREEMENT SHALL BE INTERPRETED

AND CONSTRUED IN ACCORDANCE WITH THE LAW AND PROCEDURES DEVELOPED UNDER THE FAA. THE PARTIES SHALL MAINTAIN THE CONFIDENTIAL NATURE OF THE ARBITRATION PROCEEDING AND THE AWARD. YOU AGREE THAT BY PARTICIPATING IN THE 24 DAYS EVENT, YOU ALSO ENTER INTO THIS AGREEMENT TO ARBITRATE FREELY AND VOLUNTARILY AND WITHOUT ANY FORM OF COERCION, DURESS OR UNDUE INFLUENCE.

**12. VOID WHERE PROHIBITED:** The 24 Days Event is void where prohibited. All federal, state and local laws apply to the 24 Days Event. Decisions regarding all matters relating to the 24 Days Event that are not addressed in these Official Rules shall be made by Sponsor in its sole and absolute discretion, and each Participant agrees that all such decisions shall be binding and final. Failure to comply with these Official Rules may result in disqualification from the 24 Days Event at Sponsors' sole and absolute discretion. Sponsor reserves the right to permanently disqualify from any promotion any person they believe has intentionally violated these Official Rules.
